What changes would UUCA have to make to accommodate the growth of 100 more people?

# Zoom conference with Keith Kron, UUA Director of the Transitions Office, to provide basic information about selecting the search committee for settled ministry:

- Our situation is common because there are 35-50 settled ministry searches each year.
- Our situation is unique because we are a larger congregation and we had a settled minister for 34 years.
- The Board and Congregation need to determine what kind of settled ministry is best for us. Does co-ministers or one senior minister best serve our situation?
- The Interim Process takes time and needs to be done well. Part of the interim process is to identify unspoken expectations, things Fred took care of that others did not know.
- Key dates for the Settled Ministry Search Team: April 2019 selected; May/June Retreat; Summer lots of work; August-October Survey; September-October Cottage Meetings; November compile congregational record and information packet; December interested ministers examine information and notify Search Committee of their interest; January 2020 Initial discernment; February/March look at possible candidates; March 26 Offer date; April Candidate Week and Congregation votes.
- Inside candidate: An inside candidate is considered before the Search Team is selected. If the inside candidate is to be a part of co-ministry, that person participates in the Search process.
- The process of choosing settled ministry is a tremendous and exciting opportunity for the congregation to position itself for the future.
- Board, Nominating Committee and Governance Team will meet with Keith and Kate Walker, UUA Transition Coach, on September 17, 2018 at 7pm. The Board members shall forward questions to Heather by Friday for her to forward to Keith and Kate.

#### • Financial Officer's Report: Kari

- The financial data for August is not yet available. The 2018 pledges to date are roughly \$34,000 under budget but this is not unusual for the end of summer.

#### Senior Minister's Report: Kathleen and John

- Recent use of the Disruptive Behavior Policy for a member of the Sangha group after much due process by the Sangha group and the executive team.
- Report of constant tension between middle hour groups for space we have too little, large meeting space.
- Expressed the need for a building supervisor.
- Discussion of 2 grants obtained by John: Chalice Lighter grant for a total of \$20,000 over 3 years to fund Joshua Long's position and UU Funding Panel matching grant of \$7,000 to grow membership and increase racial diversity.
- Discussion of how the Board provides feedback to senior minister regarding the senior minister's "interpretation" of Ends Statement.
- Discussion of the Board's responsibility to manifest for the executive team our support for the Sanctuary and 8<sup>th</sup> Principle that were sanctioned by the congregation. Heather, Dianne, and Kari will meet with Kathleen and John to explore this further.
- Discussion on how we prioritize how much we give to outside groups.
- Discussion to permit Paul Jorgenson to further explore the needs of our physical structure. Kathleen will contact Paul about getting others to help look at facilities usage and needs.

Discussion of how our meeting was conducted in light of the 8<sup>th</sup> Principle to dismantle racism and other oppressions in our work on the Board.
